As you may know we are members of Civic Voice, a national charity for the civic movement in England. As part of this organisation we receive a series of updates of activities, news worthy events etc.. Currently these updates are not necessarily circulated to all interested parties. Therefore we would appreciate a volunteer who can act as a coordinator for these updates and distribute them according to an agreed matrix. No experience is necessary apart from having and be familiar with Email.

As of writing the new 'Balanced Network' has just been opened, somewhat later than originally planned... It will be very interesting to see how the scheme performs, as we had concerns about the scheme at the planning stage, but hope the new layout reduces delays as expected, although there may be some teething problems as drivers adjust to the changes.

The possible additional runway at Gatwick is still creating a lot of local interest and we will be getting involved with the various reviews and consultations as the infrastructure impacts will also need to be considered for the possible increased passenger numbers, aircraft noise, employment issues and transportation. Based on information regarding the current, and possible future noise corridors, both from Gatwick and Heathrow, we have reviewed our previously neutral stance and now oppose the plans for the additional runway. It is useful to note that a number of local Boroughs are against the proposal, which does strengthen the case for the additional runway not being approved.

We are following the discussions that are taking place between rail users and both Network Rail and the rail franchise holders, although our input will be limited.

The work on the Memorial Park is complete and is open for the public. This is a welcome improvement to this fine open space in central Redhill and hopefully it will be well supported as the weather improves. Planning applications are still being reviewed and comments submitted, one of particular interest is the application for Tesco convenience store on the site of the car showroom at Shaw's Corner. It was previously rejected and with Tesco current problems are they serious about this development?

Nominations for the 2015 Awards are now requested, so if you know any project you think worthy of consideration, and then please let us know. The only entry qualification is that the project must be complete and in the Borough.

You can still receive free vouchers for limited access to National Trust sites, but applications must be made in writing. English Heritage vouchers are still available electronically.

Finally; a reminder that all our Open Meetings are now at the Colman Redland Centre, 33 Croydon Road. Reigate RH2 0LZ; please come and join us, as we have an exciting selection of speakers for the coming year.

COMMITTEE REPORTS

ARCHITECTURE & PLANNING CHAIRMAN: GWYTHER JOYCE (01737) 249434

The works in Redhill to renovate the Sainsburys site continue apace. The demolition of Lombard house is progressing quickly, but as of mid-February a contractor had not yet been appointed for construction of the new works, so let us hope that the site will not remain inactive for too long, as there will be a big gap in the streetscape of the town. Building work is planned to get underway this Spring, with a final completion date of summer 2016.

Staying in central Redhill, the change in traffic flow has now been implemented. For the rest of March drivers can only exit the Belfry car park by turning left, but this will change to two-way by the end of the month. The Regeneration chief, Councillor Natalie Bramhall is sure that the system will improve Redhill by reducing the number of cars entering the town and ensuring that, once in the system, they can now reach their destinations more efficiently. However, Reigate and Banstead Pedestrian Forum are yet to be convinced of the benefits: "The crossings around the roundabouts were holding up traffic, but they're still going to be there. I'm not sure there's enough room for lorries, and with the building work there's an amazing amount of lorries bringing stuff into town".

The committee remain concerned over the proposed alterations to the RNIB site, including the construction of 117 new homes and facilities on land near Philanthropic Road. The scheme would see the demolition of a number of long-standing buildings on the site. The Environment Agency has highlighted the increased risk of floodina. Reigate's Conservation Officer says that "Substantial harm to or loss of a grade II listed building should be exceptional" and whilst he has not raised any objections, this is predicated by a 12-part condition. The impact of the development on the Tudor House (the former site of The Philanthropic School, regularly visited by Charles Dickens) and the fact that the development is in the Green Belt are both of particular worry. The scale of the development is likely to impact upon local infrastructure, including traffic congestion, as well as schools and doctors' surgeries.

At Gatwick, the council have not opposed plans for a 2nd runway at the airport, Deputy leader of the Council Allen Kay has said that they will 'not support or object to 'the proposed plans, hoping to secure maximum benefits for residents and businesses whilst at the same time inevitable negative impacts are minimised'. There are considerable concerns ranging from noise issues and air quality to greater risks of flooding housing and and impact on social councils infrastructure. Most local have opposed the plans, and if Reigate and Banstead had added their voice this would have carried substantial weight. The Gatwick Area Conservation Campaign has issued its reply in the form of, the Response to the Airport Commission's Consultation on Runway Options. A number of A&P members have read this document and consider it both creditable and well-researched.

In Reigate, work has started in converting the old Surrey Mirror offices on London Road into what is believed to be a Co-Op at ground-floor level with flats above. Whilst the renovation of a space which has lain unused for four and a half years is to be welcomed, there is the strong possibility of a negative impact on traffic circulation which already has to contend with the level crossing gates and school run traffic.

Anyone recently visiting Redhill cannot fail to have noticed the changes. Two-way traffic around the Town Centre was adopted on 15 February. Lombard House is nearly completely demolished ready for building the enlarged Sainsbury. The 'Liquid and Envy' site is now clear except for the facade.

Although now two-way work on the balanced network continues, the footpath from the station to the pedestrian crossing across Princess Way is being widened. This results in traffic having to go down to one lane at the roundabout with congestion nearly as bad as before Christmas. There also will be resurfacing on many of the roads around the system in the near future. No doubt when the new Sainsbury is built there will be further disruption. While the balanced network is incomplete it is premature to decide if the system is a success or failure. Signs so far are not good. It is clear that congestion down Redstone Hill is worse. This is in part due to the new cycle path under the station bridge. Thus traffic can only sort into two lanes for those turning right and those turning left very close to the roundabout. There seems to be problems with long articulated lorries at a number of quite sharp bends. The exit from the Belfry car park is a problem, especially for cars wanting to turn right. Another problem for both customers and service vehicles is at the new mini-roundabout at the entrance to the Belfry. The *Surrey Mirror* has very recently published new images for the Marketfield site and the canopy over the entrance to the Library and Harlequin. We await submission of detailed plans for the development.

I mentioned last time on planned new map based Travel Smart direction signs. These have not appeared, instead there are a number of new pedestrian signposts.

TRANSPORT

ROADS: Separate petitions for a 20mph limit in Reigate High Street and for a pedestrian crossing near the Esso Garage on Reigate Hill have been passed to the Council.

GATWICK AIRPORT: Reigate Society letters opposing the Gatwick second runway have been sent to the CAA, the Airports Commission and the Surrey Mirror (which was published).

EXTRA HOUSING: The proposed 1500 house development in north Horley will put extra strain on roads and be under the Gatwick flight paths. It could require improvements to the local roads. Drainage and water run-off are also considerations.

RAILWAYS: Network Rail has issued a draft Route Utilisation Study for Sussex. This proposed many improvements (mostly without specifying dates) such as additional platforms at East Croydon, grade separated junctions at Purley and north of East Croydon. The additional platform at Redhill is scheduled for completion by December 2017 when 3 trains an hour from Reading with 2 going on to Gatwick is a possibility, increasing pressure on Reigate level crossing. An additional 12 car platform at Reigate was mooted - in future; all trains to London will be 12 cars. The present rush hour scheme with Three Bridges / Tonbridge

and Three Bridges / Reigate splitting at Redhill cannot be supported because of the time taken separating the trains. Network Rail proposes to retain the Tonbridge / Three Bridges service but run 12 cars to Reigate for the other service. The new platform would be behind Platform 2 and would occupy some if not all of the car park. Our response was to suggest splittina Reigate/Tonbridge trains and having 12 cars running to Three Bridges requiring no infrastructure changes.

When the Gatwick Express service was a separate franchise, Southern held down fares to provide competition. Consequently, a season ticket from Gatwick to London is presently cheaper than one from Redhill or Reigate. Similarly, fares from Godstone were held down when that line had inferior rolling stock and a worse service. It now has the same rolling stock, a better service to London Bridge during the present disruption and cheaper season tickets. The fares structure is now fixed with annual percentage increases. The Department of Transport does not have want to change this despite representations from MP Crispin Blunt. The reduced rush hour service to London Bridge has been well documented in the press.

NATURAL AMENITIES

Reigate Heath

Ian Wright and his team are proceeding with the schedule of works in the current Management Plan, and are helped by the **Reigate Area Conservation Volunteers (RACV).** The process for the drawing up of the Management Plan for the Heath from March 2015 has been started.

The **RACV** has one work day scheduled for Reigate Heath. **Sun.29 Mar. REIGATE HEATH SSSI & LNR** – **Heather Restoration.** Continuing this season's heather restoration programme. Clearing tree and scrub cover together with later turf/litter layer stripping to allow the heather to regenerate from seed. Meet in the Flanchford Road car park from 10am. Session usually finishes at 4pm. Grid ref: 239503/Postcode: RH2 8AB. Any member of RS or the general public would be welcome to this working party. Please wear suitable footwear, clothes and gloves. Find out about the intricacies of managing this SSSI. Young people under 16 years must be supervised by an adult.

Reigate Heath Residents' Association: The Reigate Heath Residents' Association Constitution (10 July 2013) states that the area of interest includes properties and land comprising Flanchford Road to the north of the junction with Clayhall Lane, Bonnys Road, Reigate Heath, Heathfield, Trumpets Hill Road, Sandy Lane, Buckland Corner, Buckland Road, Cliftons Lane, Colley Manor Drive and Colley Lane. Residents of these roads are automatically members. Relevant planning application details are circulated to the group by email and another social get-together is organised for early March. The RHRA Committee has been actively working to seek ways of reducing the speed on West Street, ensuring safety for pedestrians and riders crossing the A25 at Flanchford Road. Repeater signs for the 30 mph limit on West Street have now been installed in an effort to slow drivers either approaching or leaving the town.

They have written to Surrey County Council asking them to consider an extension of the 30 mph limit west on the A 25 and on Flanchford Road. They are also in discussion with Surrey County Council to try and resolve the flooding issue on the bend near Sandy Lane on the Flanchford Road as well as the condition of the road edges further along.

Liz Hale has resigned as Chairman having been instrumental in setting up the Residents' Association, and Harry MacMillan who was Vice Chair has stepped in as Chairman until the AGM. He can be contacted by email at the following address: hjoycepippin@aol.com.

There has been a proposal to denotify some of the wetland area parts of the SSSI encompassing Reigate Heath. This is in response to the dramatic lowering of the water table and the drying out of these areas. Natural England does not believe that the cessation of sand extraction will lead to a natural restoration of these areas which lie to the south east and south west of the main area of the heath.

Earlswood Common. Attempts continue to identify the source(s) of the contamination which affect the water quality of the lakes. Until these investigations are complete it will be difficult to improve the state of the lakes. The clearance work in and around the chain pond has been completed by the Conservation Volunteers ready for the desilting work to be undertaken by R&BBC contractors.

Common Land. R&BBC has also been made aware of incursions into common land by the new development at Somers Gate (the former Dovers Care Home) in Dovers Green Road and this will hopefully be restored shortly. There may be other incursions also within this area of council owned common land which will need addressing.
