I mentioned in the last Newsletter the new 'Balanced Network' had just been opened. Although I had some concerns about the success of the scheme I am pleased to report that based on personal experience it seems to be working well, although I understand the rush hour traffic is still very slow.

Although it has been announced the new runway for the south east will be at Heathrow the possible additional runway at Gatwick is still being mooted, especially by Gatwick Airport We will still be getting involved with the various reviews and consultations as the infrastructure impacts need to be considered for the possible increased passenger numbers, aircraft noise, employment issues and transportation. As mentioned previously we still oppose the plans for the additional runway. It is useful to note that a number of local Boroughs are against the Gatwick proposal, which does strengthen the case for the additional runway not to be relocated from Heathrow.

The work on the Memorial Park is complete and is open fully for the public. This is a welcome improvement to this fine open space in central Redhill and hopefully it will be well supported.

You can still receive free vouchers for limited access to National Trust sites, but applications must be made in writing.

### SECRETARY'S NOTES

The 63rd Annual General Meeting took place on 13th July in the Colman Redland Centre. Around 60 members were present. The business of the AGM, the approval of the Minutes of the 62nd AGM and the adoption of the Annual Report and Accounts was completed by members present. Alan Mortlock stressed that he would be seriously considering the winding up of the Society if volunteers were not found for the five current vacancies. He will have completed his 5 years as Chairman by the next 2016 AGM and the Reigate Society Constitution "states "no person is eligible to hold the office of Chairman or Deputy Chairman for more than 5 consecutive years." At the time of this, the 63rd AGM, there was no Vice Chairman and no volunteer for this position, prior to the meeting, and no nominations from the floor. The following were elected to office: Alan Mortlock (Chairman), Robert Bogin (Hon. Treasurer), Cara Hunter-Rowe (Hon. Registrar). All four retiring members of Council had allowed their names to go forward again. John Cumberland, Sean Hawkins, David Paxman and Ian Stronge were all re-elected. One request made by several members has been for letters/email reminders to be sent out each year when subscriptions are due. Approximately half of our membership is on email and we are investigating the option of sending e-reminders. However we are unable to fund postal reminders, but our Newsletters advise that payments are due in or around April each year and a payment slip is attached to the back of the 'Corporate Members List' sheet in our April Newsletter for your assistance.

# **COMMITTEE REPORTS**

### ARCHITECTURE & PLANNING CHAIRMAN: GWYTHER JOYCE (01737) 249434

As we approach this year's Members Evening preparations for the Civic Award selection process has commenced and to date we have attracted six nominations. The new award category as mentioned in our previous newsletter covers Shop front improvements and new shop developments. For your information the full list of seven award categories follows and any further nominations by any of our members or the public will be welcomed. All nominations must have been completed within the last 12 months and must be located within our borough.

- New buildings
- Conversions, improvements and adaptations
- Conservation and restoration
- Exterior decoration
- Street or road layout improvements
- Tree planting, gardens and landscaping
- Shop front improvements and new shop developments

This year and in future years, in conjunction with the Civic Voice we will be entering the winners of our award programme into a National Award Scheme. We are very keen to ensure some commendable projects are put forward and therefore you are encouraged to email or post any suggestion to myself or complete the nomination form to be found on our website.

The Reigate Society 60<sup>th</sup> anniversary sculpture project unfortunately remains in limbo due to the absence of a sponsor for the construction of the brick base. Several members of our society are pursuing options to complete this long overdue project for which we have set a target in completing by the endo of 2015. Through this newsletter I would invite any sponsor to contact myself or Alan Mortlock if they wish to offer either the skills or the funds to complete this work.

The most important centre for urban redevelopment at the heart of our borough remains in a disappointing state, being the central business district of Redhill. Much has been promised and no doubt in time we will see a transformation of the area, however right where we should be seeing some handsome new buildings we have two very ugly abandoned demolition sites and two bleak and uncompromising large car parks. The situation can only get better.

The monthly review of planning applications throughout the Borough continues as usual and comments submitted to the planning department.

These can vary in size and the quality of proposals cover a wide spectrum. One of particular interest has been the application for new housing on the current industrial unit at the corner of Hooley Lane and Brighton Road. The recent report in the Surrey Mirror about this development was not accurate as the number of units quoted was for each block, and there are four block proposed. This appears to be a serious overdevelopment and will surely lead to parking and other traffic problem, as the area has also a new development on part of the old Sea Cadets site. Also the future of the old Redhill station and train sheds which have historic value need to be considered.

The pressure on the Borough due to Government and European immigration policy to build new houses has had the very noticeable effect of intensifying the number of backland developments being submitted. These have been seen with gardens being divided and built on, houses demolished and several homes or blocks of flats built instead, and parking allotments redeveloped. Also there has been the noticeably strong growth in conversion of existing office buildings into flats which to some degree has been understandable as overprovision of offices in the area has been very apparent. Overall and more troubling to our committee has been the tendency to reduce the size of new homes to the bare minimum size. While first time buyers must be catered for, it is our view that building shoe box size homes will be divisive, socially unacceptable and potentially create slums of the future.

Over the decades, our borough has consistently acquiesced to excessive new housing numbers demanded by Government and this has produced the threat to Green Belt land. It would now appear the borough is allowing backland and brownfield overdevelopment to contain the pressure for new homes before it spills out onto Green Belt land.

In conclusion the Architecture & Planning Committee has a very busy programme of monthly meetings and we are always looking for new members to join in our stimulating discussions. We are fortunate this year to have attracted another professional but we are always looking for any member who has the best interest of our unique built environment at heart.

### REDHILL

Since my last report, apart from completion of the balanced network road works, there has little visible progress on the other projects in Redhill. Two-way traffic seems to be moving smoothly most of the time with the exception of some congestion on the routes to the Station roundabout. It is partly caused by the reduction to only one lane entering the town from Redstone Hill. There is related congestion from traffic leaving the town turning left under the railway bridge. It is caused by increased periods when the traffic lights at Noke Drive are red.

The other part of the balanced network project, refurbishment of Station Road East, is complete. Two of the trees in the four new planters do not seem to have survived, probably due to lack of water. The seats in Maple Square, that were removed in the refurbishment, have not been replaced.

CHAIRMAN:

Work on the enlarged Sainsbury's seemed to be progressing well until it came to a halt with the bankruptcy of the appointed construction company. Reports suggest a new firm has just been appointed. There is little sign of work on the Liquid and Envy site or construction of the multistory car park by the station.

Without much publicity in June the Borough issued its booklet on *Reigate and Banstead remembers World War I* programme for 2015 (available from the library or on the Borough website). Of note is that a memorial stone to Rupert Hallowes, awarded the Victoria Cross in 1915 for his actions at Hooge, Belgium, will be laid in the Memorial Park on 25 September. Rupert was born in Redhill.

### TRANSPORT

CHAIRMAN: BRUCE HEALEY (01737) 240577

As I'm sure most will already know, the Airports Commission found in favour of an extra runway at Heathrow to the relief of most people in this area. This decision has still to be ratified by a Parliament Committee chaired by the Prime Minister and the prospect of a second runway at Gatwick has not been ruled out as an addition. The proposed changes to the local bus services go ahead on 29/30 August. In summary, the 540 (Woldingham to Redhill) is withdrawn; the 424 is to change from half hourly to hourly and the 357 will no longer run direct from Redhill to Reigate but will instead follow the route of the 424 to supplement that reduced service. A lesser advertised change is that there will be an extended route, the 485, from Reigate Red Cross to East Grinstead. Any enthusiasm for this is tempered by the fact that there is only one through bus per day. Full details of the changes and timetables for the various operators can be found on the web.

As ever, there are many roadworks in the area, the main ones are on the A25 at Betchworth, which should have been cleared by late August, and on the A23 at Hooley which should finish in mid September.

The recent merging of the Southern Trains and the Thameslink/Great Northern franchises has proposed some interesting and generally beneficial changes to local off peak services from December 2015. So far these are proposals and are yet to be confirmed. Reigate and Tonbridge trains will miss out Merstham, Coulsdon South and Purley and will run to Victoria rather than London Bridge. There are two proposed Thameslink trains an hour calling at Redhill, Merstham, Coulsdon South and Purley through to Blackfriars and St Pancras International etc. There will still be other services from Redhill to London Bridge. However, the Portsmouth Harbour/Southampton/Bognor Regis trains will no longer call at Redhill to facilitate the above proposals. These proposals would not affect the rush hour services.

### NATURAL AMENITIES

RBBC has apparently reactivated its Green Infrastructure Strategy but there was little consultation undertaken as closing date was 29<sup>th</sup> May.

#### Waste Disposal.

SCC is engaged in a cost/ benefit analysis of their waste services. This could lead to the eventual closure of some waste sites where they are under-used involving longer travel to amenity sites for some residents. It is not thought that this would apply to the larger site within the borough. Any changes will presumably be made known during 2016 when the Waste Plan is due to be reviewed.

#### Priory Park.

It is understood that RBBC has called for the reformation of a Friends Group with the intention of setting up working parties to undertake tasks in the park. The Society was neither informed nor invited to participate.

#### **Reigate Heath.**

The Management Plan is to be extended in its current form for a further two years as there is no clear agreement as to what should be included in any replacement plan. The draft questionnaire on the future of the heath which has been proposed to help progress this issue appears to be biased CHAIRMAN: COLIN BURBIDGE (01737) 245264

and confused and will not do solve the way forward. Clarification of the relationship between the RA, RBBC and the Steering Group is required before any significant progress can be made.

Additional funding for maintenance of the heath is being sought to match that released from the residue of CAMEL fund.

The lease on the cricket pitch ceased in August due to the demise of the cricket club.

#### Earlswood and Redhill Commons.

The growth of vegetation around the Chain Pond has been remarkable since the clearance over the winter period but the recent Management Group walkabout was poorly attended.

There are reports that the lower dam on the lake is leaking.

#### Wray Common.

The more environmentally friendly mowing regime adopted over the last two years was abruptly changed for this summer without consultation. Despite it being drawn to RBBC's attention that this was in conflict with its biodiversity objectives the 'accidental' use of the wrong mowing regime has recurred on subsequent occasions. The reasons are still being sought.
