# **CHAIRMAN'S NOTES**

The Society is concerned at the increasing density of population in our borough because it is not accompanied by increased facilities such as schools, doctors' surgeries, public transport. Added to this the amount of parking in the borough is likely to reduce rather than increase, for example proposals to develop on the Gloucester Road car park in Redhill and on the Town Hall car park in Reigate. The main pressure from Central Government on all local authorities to build more homes is understood but it must include expansion of insfrastructure whilst at the same time protecting the Green Belt in the area. Our committees are constantly monitoring these matters and we remain vigilant in maintaining our borough as a pleasant place to live.

For ten years the Society has co-ordinated Heritage Open Days. This year we have combined with Reigate and Banstead Town Hall and representatives of many of the venues to form a working group. This is to spread the load of co-ordinating the brochure and events. Fliers and brochures have been widely distributed throughout

Reigate, Redhill, Merstham and Horley and we look forward to an even greater attendance at the many historic and interesting venues and at the talks and walks which are taking place. At the edge of our area, a rather smaller developer from Billingshurst proposes a "garden village" at Redhill Aerodrome. Among other considerations, this may depend on the business case for a new link road junction on the M23. It will be interesting to see whether Tandridge District Council adopt this as part of their Local Plan – their Garden Village proposals are out to consultation until Monday 9th October. Adjoining the site, East Surrey Hospital is also applying to remove Green Belt protection against further development, including perhaps nurses' homes.

Smaller, more convivial projects include the reopening of the Garibaldi on Mill Street as a community pub, a project initiated by a 'Friends of...' group on Facebook. We wish them all success. It will be interesting to compare their offering with the "classic gastro pub" planned by the new owner of The Hatch at Linkfield Corner.

## TRANSPORT

#### Trains:

The RMT/ASLEF vs Southern dispute rumbles on after 16 months. The positions of the relevant parties are now totally entrenched and a solution now seems unlikely. The Government has blamed the Unions and are very unlikely to retract from that position. ASLEF have rejected a 24% pay rise claiming that this is not about money, so they now cannot back down. The RMT have had 4 offers from Southern Trains none of which they have put to their members for a vote, implying that they will absolutely not back down. Southern are required by the Department of transport to implement Driver Only operation of the doors and are well and truly caught in the middle.

Moving at a speed which makes Continental Drift look fast, Transport Minister Chris Grayling has at last engaged in discussions with the unions. At the time of writing this (early August), these talks and the separate talks between Southern and the RMT have stalled. The stand-off continues with no sign of a resolution.

The work at London Bridge continues; the August Bank Holiday closures should little affect the Brighton Line. Although the work is due to be completed by the New Year, the full new Thameslink timetable will not be introduced until May to allow for driver training.

Redhill Platform 0 work is progressing and should be complete for the Christmas to New Year closedown to implement the track and signalling changes.

## **Reigate Level Crossing:**

It is a franchise requirement for GWR Trains to introduce an additional hourly service each way

between Gatwick and Reading. This is dependent on the Redhill Platform 0 work completing and there being enough trains cascaded from the faltering Paddington electrification. This will considerably impact Reigate level crossing. I have sent a letter to MP Crispin Blunt and Surrey County Council recommending a course of action to reduce the times the gates are closed for each train which, if implemented, would substantially offset the effect of the additional trains.

#### Air:

The Government has fixed the number of night flights at the current level. Regarding the noise quota, the summer night time permitted level remains the same but there is an apparent risk of

an increase in winter.

#### Roads:

Reigate and Banstead Council have announced as £3.6m Community Infrastructure Levy plan for the next 5 years. Some of this will relate to transport with a number of schemes for cycleways, improved junctions and improved public transport.

#### **Buses:**

The new timetables were published on 1st August and become effective on 2nd September. There do not appear to be any drastic changes.

# **NATURAL AMENITIES**

At this time last year we were anticipating the consultation phase of the borough's Development Plan mindful of the fact that actions taken by the borough council were suggestive that all was not well with the management of our open spaces.

This suspicion has proved to be correct as we now know that the Green Spaces Manager and the Tree Officer have recently departed from RBBC leaving a severely depleted team (in tandem with the Steering Groups) to deal with the ongoing issues surrounding the management of Reigate Heath,

Earlswood & Redhill Commons and the formulation of the continuing Management Plans for these areas. There is also an issue with the overuse of all our open spaces which will begin to suffer if not it is not addressed.

There has also been publicity recently concerning the use of and possible closure of SCC's recycling sites. It is understood that there is to be a consultation on revisions to the Waste Plan this autumn.
