Reigate is well known for its 'caves' which riddle the town centre, although these are in fact largely old sand mines. The castle mound overlooking Reigate town centre is composed of soft sandstone and has been mined over several centuries. The castle has long gone but the mound and many of its excavations still remain.

#### **RRS CHAIR NOTES - PIPPA MARTIN**

The Beer Festival organised by Redstone Rotary Club in Reigate Tunnel from 15<sup>th</sup> to 17<sup>th</sup> May was a great success enjoying excellent weather and making in excess of £20,000 for charities.

The Reigate and Redhill Music Festival ran from 17th to 23<sup>rd</sup> May. The Reigate Arts Festival is to be held on 20-22<sup>nd</sup> June. There are regular musical events at the Cage and Reigate Priory Football Club. Reigate is a busy and thriving town.

Redhill is suffering severely from the loss of the Harlequin and Marks and Spencer and the centre is looking very sad and neglected. The many empty shops with boarded up fronts lend an atmosphere of decay. The market is struggling with no flower stall and fewer traders.

Andy Nash keeps the Belfry looking busy and vibrant despite the drop in footfall. The library operating from the first floor plans to move back to the Warwick Quadrant in September.

The NHS diagnostic Centre is planned to move to the first floor of the Belfry within months.

The Harlequin Support Group maintains its active fight for the return of the theatre, emphasising the loss of community space, the damage to the local economy and trade, Loss to musicians, performers, restaurants and arts education and opportunities for young people to develop confidence and talent. Kate Hymas the borough development officer discussed the Arts takeover in Redhill in October. The society is publishing her article in this Newsletter.

Concerts at St Johns and weekly concerts at St. Matthews continue

The Society was invited to complete a survey on Surrey's 10 year health plan which the Chairman completed.

The residents of Surrey were invited to comment on the Local Government Reorganisation and a webinar was held on 13<sup>th</sup> May. The Chairman objected on the grounds that Reigate and Redhill would lose its identity and inherit other borough's debts. Members of the Council stated that the Government would absorb the debts.

#### **RRS CHAIR NOTES – PIPPA MARTIN (continued)**

No suggestions for Civic Awards have been submitted so none will be awarded this year.

The future of the Community pub The Garibaldi in Mill Street, Redhill was discussed. It is a is a not-for-profit pub run by volunteers with all profits reinvested back into the venue. It currently runs under a lease but the owner wishes to sell. The landlord has been very supportive but the pub now needs to purchase the freehold to secure its long term future as a community asset. The Garibaldi is financially stable and well supported. Many avenues are being explored to secure funding.

The RRS Council agreed to "pledge" £500.00 subject to guarantees that this would be returned in the event that the sum required was not obtained.

The Reigate & Redhill Society were informed that on 14<sup>th</sup> May Solum appealed against the Borough's decision to refuse planning permission for "tower blocks" to be built in the forecourt of Redhill Station. The council agreed that the development would be disastrous for Redhill and Robert Bogin and Pippa Martin attended an ERRA (East Redhill Residents Association) meeting on 23<sup>rd</sup> May at the Home Cottage and pledged the society's support. The enquiry is to be held on 8<sup>th</sup> September 2025.

Net income at year end 2024-2025 was £84.91 Membership subs 2024-2025 were £3082 - previous year was £2982 Balance sheet figure is very healthy

#### **REGISTRAR'S REPORT - ROBERT BOGIN**

Number of members at year end was 371 comprising 98 single memberships, 123 family memberships, 20 corporate and 7 others. Thus a total of 248 memberships. The number of new members joining in 2024-2025 was 24. The number of memberships unpaid for 2024-2025 is 23; reminders have been sent out

#### **ARCHITECTURE AND PLANNING GROUP – TIM LEE**

The APC reviewing and discussions on current planning applications as consultees for RBBC continues as a major role of the committee.

We are also keen to find out in the coming months how the strategy for a new East and West Surrey Council structure is to be implemented and the impact on local sites and buildings such as those used by the borough and county council.

In the meantime there are projects such as the Solum development of Redhill train station and the application for a new Priory School building on the Woodhatch Place. The application for the new Priory School specifically is still open and there have been some amended documents submitted recently that will be reviewed at another planning committee meeting possibly in July. These revised documents do not seem to have changed much following the refused design so it is hard to see how this will be viewed positively by parents and residents alike.

#### The Civic awards 2025

We have unfortunately made the decision not to hold a Civic awards for this year. This is due to the lack of nomination from members of any worthy projects to be added to the judging list. We as a committee have struggled to recall any successfully completed projects in the last couple of years that would warrant a nomination.

We very much hope that we will have more nominations to be able to form a shortlist and hold the awards in 2026.

Projects can range from outstanding buildings to public sculptures, and we will draw up a short list from the nominations to be judged next year.

#### New chairperson required:

#### TRANSPORT GROUP - BRUCE HEALEY

There have been many partial closures of the A3/M25 interchange in the last month or so. At the time of writing there are no further dates announced. The works on the eastbound M25 to add additional refuges on the 'smart motorway' section are nearing completion and the speed limits should soon be removed. Similarly the works on the M3 and M4 are nearing completion.

The Gatton Park Road closure is due to finish in early to mid June depending on which report you read.

The Redhill to Tonbridge railway line is scheduled for a 9-day closure between Saturday, August 16, and Monday, August 25, 2025, to facilitate engineering works with a bus replacement service covering the whole route.

The recent timetable changes have made very little difference to local bus and rail services. There is a proposal for operator Great Central to run a train service from Brighton to Newcastle via Redhill, Reading and Oxford. 5 trains per day in each direction are proposed. Good news for rail travellers but less good news for users of Reigate level crossing. If approved, the services would start in December 2026.

At Gatwick Airport, the drop-off charges have been increased yet again. It will now be a rather exorbitant £7. In an attempt to soften views about the second runway, the airport has agreed to tighter noise limits

Stand with Us: Save Redhill from Overdevelopment

Dear Friends,

The Reigate and Redhill Society has joined forces with East Redhill Residents Association (ERRA) to support a newly formed Redhill Residents' Action Group (RRAG), it will be a collaboration of several groups. Together, we are fighting Solum's appeal against the council's refusal of their application to build five buildings in two blocks of up to 15 storeys high on Redhill station.

We believe that the proposed development is the wrong development in the wrong place. It's too tall and the plan to move the taxi rank and drop-off (and eventually all the parking) to Redstone Hill will create chaos in Redhill; vehicles will be required to turn right across a heavy stream of downhill traffic on a blind bend to access the station. It will make it more difficult for traffic on St Anne's Drive to get onto Redstone Hill and it will increase pollution levels for pedestrians, commuters, and children walking to school. It will affect commuters in Reigate - not just Redhill.

Ballet and Line Dancing workshops


Art, poetry, writing, jewellery and pottery workshops

### The Garibaldi Community Pub

Friends of The Garibaldi Community Interest Company (CIC) Ltd was formed in 2017 to save the Garibaldi pub from closure and conversion to housing.

As a CIC we are limited by Guarantee and so have no shareholders. We are a not for profit company: all income is reinvested into the company and only the manager and bar staff are paid. All the Directors are volunteers, and receive no remuneration for their work.

We've now reached a pivotal moment in the pub's story. The building is privately owned by someone who has always been incredibly supportive of the project, but who has now decided that the time is right to sell. He kindly offered us first refusal, which we accepted in 2024. Purchasing the building would allow us to secure the pub's long-term future. The Garibaldi is financially stable, well supported, and has shown that it can succeed. Ownership of the building would open up further opportunities to grow and improve the space, helping us protect it as a community asset and do even more for the people of Redhill.

We've explored many funding avenues, including grants, campaigns, and ethical lenders, and continue to pursue all realistic options. The timing of national events has unfortunately affected some of our plans, and the funding environment has proved particularly challenging since last year's general election. Nevertheless, we remain committed to finding a solution that ensures the pub stays in community hands.

When we committed to buy the building last year we exchanged contracts with the agreement that we would complete in June 2025. However the aforementioned general election scuppered these plans, as the Community Ownership Fund (COF), which we were about to send our grant submission to, for 80% of the purchase price, closed.

We are regularly in dialogue with the current owner, who has very generously allowed us a year's further extension to June 2026 on the proviso that we pay him £62,000. This is in addition to the £72,000 we paid last year when we exchanged contracts. We have £42,000 available in our bank and need to raise another £20,000 ASAP.

After we have formally extended the contract for another 12 months we then need to pay the balance of £486,000 as soon as feasibly possible, and no later than June 2026. To support this we are currently preparing an application for the National Lottery, as some funding opened up there late last month. However we are aware that as all other funding closed down with the election last year they are currently 300% oversubscribed.

Our ideal scenario would be for an investor to buy the freehold from the current owner and lease the pub to us with the option for us to buy the freehold in the future, when we can secure the funding.

We are also open to the possibility of taking out a commercial mortgage, but this hinders us in a number of ways:-

- We would want to borrow no more than 40% of the balance owed as, with interest rates as they are, borrowing more than this would put a lot of pressure on our finances
- No one lets you apply for retrospective funding, so we would never be able to apply for a grant to settle the mortgage
- We still need to raise the balance between the amount owed and any mortgage taken.
